August 25, 2010

I. Introduction (James Humble, President)

IV. SEPTLA Spring Meeting/RDA Workshop

Institutional News

Lancaster Theological Seminary

The Philip Schaff Library bade farewell to Bryce Rich who has gone on to doctoral studies at the University of Chicago's Divinity School. William Marshall succeeds Bryce in the library. He brings with him Masters degrees from both LTS and Drexel's library school as well as considerable part-time experience in the Philip Schaff Library.

Instead of using an in-house index of e-journals, the Library has implemented EBSCO's A to Z list. We have replaced our dSpace installation with a new one and have been busy adding lectures and other content. One project this summer was the digitization of the *New Mercersburg Review* from 1985 to the present. This has been added to dSpace.

Riess Potterveld resigned as president of LTS, moving to California to be president at Pacific School of Religion. Rev. Kenneth V. Daniel has been appointed to serve as interim president at LTS.

New Brunswick Theological Seminary

On Tuesday October 5th, the Seminary was pleased to host a reception for Dr. Donald Hilliard. The occasion was the opening of Dr. Hilliard's exhibit in the Helen Studdiford Kleis Art Alcove, featuring over 70 works of art, paintings and limited edition prints. Bishop Hilliard is pastor of Cathedral International, a Baptist congregation of 5,000 members worshipping in three locations (Perth Amboy, Asbury Park, and Plainfield, New Jersey). The exhibit is free and open to the public.

The New Brunswick Theological Seminary 2011 Artist-in-Residence will be Rev. Adriene Thorne, Associate Minister at Middle Collegiate Church in New York City. A former Rockette and a liturgical dancer, Rev. Thorne will teach a course in liturgical dance in January 2011, and lead the faculty in consideration of movement in liturgy and church life. The seminary is grateful to welcome her to our community.

St. Charles Borromeo Seminary

St. Charles Borromeo Seminary has a new Rector and Vice Rector. Rev. Shaun Mahoney, Rector, had served on the faculty of the Seminary before serving as the Campus Minister at Temple University. Rev. Joseph W. Bongard, Vice Rector, served for many years as the President of Roman Catholic High School in Philadelphia.
